TOPIC: Question of resolving piracy, terrorism, and interrelational conflicts in Africa and the Middle East caused by the Somalian Civil War.

The General Assembly,

Bearing in mind the interests and well-being of the Somali people, which have been, and continue to be, ignored by the international community,

Guided by the three pillars on which the UN was created: international peace and security, human rights, and development,

Realizing that the Issue of Piracy hindering global trading networks in the region of the horn of Africa,

Reaffirming its respect for the sovereignty, territorial integrity, political independence, and unity of Somalia, including Somalia's rights with respect to offshore natural resources and surrounding territories in accordance with international law,

Recalling the recent Galkayo Suicide bombing that occurred on 18 December 2020, conducted by Al Shabab. Which Targeted Somali Prime Minister Mohamed Hussein Roble, killing 17, including several high-ranking Somali officials,

Maintaining Concern of the threat current terrorist organizations may pose towards the security and future prosperity of Somalia,

Fully aware of the recent situation occurring in Somalia regarding the elections, that currently puts the Federal Republic of Somalia in great danger and instability,

1. Calling for the creation of the *Somali Economic Initiative (SEI)* to which will include but is not limited to the nations of the Russian Federation, People's Republic of China, United Kingdom of Great Britain and Northern Ireland, Kingdom of Norway, Republic of



Niger, Socialist Republic of Vietnam and the United Mexican States. The initiative will be responsible for ensuring economic stability in the Somali region,

- a. Economic stability will focus on the improvement of the overall economy in Somalia, however, noting that it will take up to 5 years for Somalia to return to full stability as a peaceful self-sustaining nation,
 - i. The improvement will happen based on projects initiated in operative clause 2,
- b. Initiatives include but are not limited to the improvement of Somali Trade relations and port capabilities to improve overall economic stability by having an increased ability in Import and Export capabilities,
- c. The initiatives above are meant to improve trade relations between countries part of the *SEI* and benefit mutually as it increases the likelihood of more economic benefits to all countries, especially those based in Europe and South America,
- d. The *SEI*, will be administered by a governing body of all members part of the Initiative, with each member country electing one official to represent them in the *SEI*,
 - i. The head of the *SEI* will be determined by an election conducted by all member states representatives,
- e. The *SEI* will have a special strategic partnership with UNSOM (UNITED NATIONS ASSISTANCE MISSION IN SOMALIA), comprising of projects that favor both parties and enhance the role of UNSOM with economic development,



2. Develop various projects based on improving the infrastructure in all major cities and regions of Somalia, such as but not limited to Mogadishu, Hargeisa, Burco, Baydhabo. These projects will focus on the improvement of three aspects as Basic, Economic, and Social Infrastructure, Implemented by members of the SEI,
 - a. Projects will also prioritize the improvement of underdeveloped regions, noting which aspects are of the utmost importance, specific to that area, city, town, or village in question,
 - b. Defining Basic Infrastructure as the basic facilities and installations that help a government or community-run, including roads, schools, phone lines, sewage treatment plants, and power generation,
 - i. Improvement of specific facilities will be determined on a case by case basis, depending on the necessity and need of each region,
 - ii. Development of roads and other means of transport, such as railway, bus systems, and communication systems will be developed by a collaboration of countries part of the *SEI*, in an effort to connect various regions of the country that will enhance the economic situation in regions that were once isolated,
 - iii. Development of Schools, Universities, and other institutions will be established with every region having access to every area of education,
 - iv. Russia will introduce a cultural and educational exchange program, providing a free scholarship fund to 1000 Somalis to study in Russia, in



various fields to improve their country and ensure future prosperity in Somalia,

- c. All infrastructure projects must be sanctioned by the *SEI*, and administered by the governing body of *SEI*,
3. Inaugurate the cooperation between Somali Armed Forces, Russian Armed forces and Chinese Armed forces, to launch joint task force ‘Black Sheep’ to instill the necessary security and power towards securing majority control of Al Shabaab territory in Somalia,
- a. Noting that this cooperation is not limited only to Project ‘Black Sheep’ and will also include collaboration with the Somali Air Force, Navy, and Police force to implement various measures of National Security in Somalia and to combat piracy in the region,
 - b. Cooperation will include the renovation of Bender Qassim International Airport into a joint-use airport for both Military and Civil Aviation use, the airport will be used as a hub for ‘Flying Black Sheep’, where the cooperation with the Somali Air Force will be its hub,
 - c. Project ‘Black Sheep’ will suppress the extremist activities that are carried out by the Al-Shabaab and other terrorist organizations within Somalia,
 - d. Collaborate Intelligence Agencies with the NISA, to set up a separate unit called ‘Black Sheep Intel’, with its main objective to collect intelligence information on Terrorist networks, prevent the leaking of crucial information as well to penetrate the network of illegal pirate alliances,



- i. The Unit will have special cooperation with the Somali Police Force, in order to assist with making arrests and to prosecute criminals caught,
4. Recommends setting up the *Somalia peace and rehabilitation project (SPRP)*
- i. This will help with helping with Somalian with learning by setting up school in major cities and town
 - ii. This project should help with managing refugees coming into the country
 - iii. Working closely with the AMISOM and the Somali Armed forces to gain control of major cities in the regions under Al-Shabaab control
 - iv. Setting up this in a major city means fewer people need to turn to piracy and terrorism
 - v. .Help provide homes to homeless children and adults
 1. Provide healthcare program for Somalians
5. Mandating The construction of the International Freedom Port and Navy base in Zelia, Primary purpose will generate jobs and economic opportunities for the people and thus, decreasing the need for people to hijack ships and fall into Piracy since they will have more stability in life because of the increased economic stability in the result of the port that is built by Russia and China, in collaboration with the Somali Navy,
- a. This will limit and intimidate the terrorism and piracy issue in Somalia and will limit the terrorism in Somalia and preventing it to spread to countries nearby which are Ethiopia and Kenya,
 - b. The issue of terrorism in the Al Shabab area of influence can be gradually eliminated and facilitated by the military stronghold,



- c. Port will also serve as a major point of trade hub to export goods from Somalia and import goods from abroad, this will all be in collaboration with all countries,
 - d. Primary
6. Transferring control of the temporary leadership of the Federal Republic of Somalia to the ‘Council of Presidential Candidates in Somalia’ (CPCS), a group formed in November 2020, In the wake of the current situation regarding the delay of the 2021 *Somali presidential election*; Which currently leaves the federal government without an acting president,
- a. The chairman of the ‘*Council of Presidential Candidates in Somalia*’, Former President Sharif Sheikh Ahmed, will reside in the role of ‘Interim President’ of the Federal Republic of Somalia,
 - b. The reign of control shall last up to a period of no more than 8 months, up to which an election date shall be decided and a date for the transfer of leadership,
 - i. The tenure of leadership and control can be extended if the situation in Somalia leads to an inability to host the elections in the time frame given above,
 - c. All decisions shall be determined and decided by a vote regarding all members part of the (CPCS),
 - d. Weekly conferences will be held for the discussion of current issues in Somalia and regarding the leadership of Somalia,
 - i. The chairman has the right to hold ‘emergency’ meetings in wake of a crisis or any situation that deems a threat to Somalia,



- e. The Chairman can not make significant changes or decisions without a majority vote by the CPCS,
- f. The CPCS main aim is to provide a stable 'rule' over a temporary course of the period, in order to ensure the stability of Somalia in wake of threats by terrorist organizations.
